- 4. If another application method is determined and announced by the Board, the announcements regarding these methods will be carried out on the website of Esas Holding.
- 5. Your applications submitted to Esas Holding will be answered within 30 (thirty) days from the date your request is received by Esas Holding, in accordance with paragraph 2 of Article 13 of the Law. The replies given by Esas Holding will also be delivered to you in written or electronic form in accordance with Article 13 of the Law.
- 6. In case your application requires an additional cost, you will have to pay the fee determined by the Communiqué on Application Procedures and Principles to the Data Controller issued by the Personal Data Protection Board. If your application is answered in writing, no fee will be charged up to the first (also including) 10 (ten) pages, and a transaction fee of 1 TL will be charged for each page for more than 10 (ten) pages. If

- the answer to your application is given in a recording medium such as CD or flash memory, you will be charged only the cost of the recording medium.
- 7. Esas Holding reserves the right to make changes in the application procedures the in accordance with Board's decisions or the regulations to be enacted in the future.
